SCHEDULE - II

**NAME OF THE WORK: SUPPLY OF PHEROMONE TRAPS, STICKY TRAPS,
 DELTA TRAPS & LURES**

ELIGIBILITY CRITERIA

- 1. The Applicant shall be a Primary manufacturer of the above products. The Applicant shall be a Reputed/MNC manufacturer of the products The Technical Committee will do the selection process based on the brand value most preferred by the farmers and/or yearly turnover value of the participating company in the last 5 years and subject to other criteria as per the schedule.**

Primary manufacturer means :

1. The manufacturing unit may be in the name of the sole Proprietor/ Partnership/Company.
 2. If the unit is taken on lease, the firm (Lessee) that has taken the unit on lease should procure raw material in the name of the firm and take up all manufacturing process on its own. Further the finished product should be invoiced on the Firm bills and all the stocks should be accounted for in the name of Lessee Firm.
 3. All business transactions should be carried out by the Lessee in his name with all statutory licenses as required.
 4. The lessee should be in a position to ensure that all Statutory duties/ Taxes/ Cess etc. are directly paid by them to the concerned Authorities.
 5. The product manufactured by the Lessee should have its own brand name.
 6. Submission of the supporting documents for the above items.
2. Copy of Certificate of Registration for manufacturer of Traps & Lures issued by Industries Department (SSI Certificate/EM Part-II) to be enclosed
 3. Manufacturing Firms outside the State should have a branch office in Andhra Pradesh who is authorized to take care of marketing/business of A.P. including invoicing the goods within the State of A.P and should have GST Registration. They should furnish the Office address in AP compulsorily.

4. The Applicant shall clearly state their production and marketing experience in the business of traps and lures along with a **declaration for about (5) years including Spodoptera frugiperda lures.**
5. The originals of all the related documents need to be made available on the day of Technical scrutiny.
6. The Applicant shall enclose the performance certificate with product wise total turnover from the Organization(s)/ Department(s) for the products which they have offered in Application for the last five years, if conducted business.
7. The Applicant should furnish a self certificate stating that his firm is not black listed.
8. The Applicant must have well equipped manufacturing facility with capability to produce and supply the required quantities. The applicant should produce list of lab equipment and machinery certified by concerned State Commissioner of Agriculture / concerned District Joint Directors of Agriculture and also a certificate stating that the manufacturing unit has got well equipped laboratory and well trained personnel for manufacturing Pheromone and Delta traps & Lures and also should submit a certificate from concerned District JDAs so as to prove that the firm is actually manufacturing the traps and also impregnating the lure with the chemical which is imported in their units only.
9. The Technical Committee will have the right to inspect the manufacturing unit of the firm and if the Committee feels that the Company/ firm is not having the required documents, machinery, technical personnel and other facilities which include financial background and capacity to execute orders, the EOI application is liable for cancellation/rejection.
10. The firm shall supply the indented material to the JDAs/ADAs/AOs/mandal headquarters as per the purchase orders.

INSTRUCTIONS TO APPLICANT MANUFACTURERS:

1. The manufacturer should submit their Application to the Corporation, on or before **12.00Noon on 22.8.2019** along with the Demand draft for **Rs.2.00 lakhs** drawn in favour of **APSAIDC Ltd., payable at Vijayawada**, towards EMD. Application without the EMD will be rejected. Those who have earlier submitted the EMD DD in the previous year for the products can submit a letter for exemption for the relevant schedule
2. The technical information, which contains details of organization etc., and all document/evidences pertaining to supply of Pheromone and

Delta Traps & Lures, along with specifications and standards are to be furnished along with the Application.

3. The rates quoted shall be for the packed traps & Lures. The rates quoted should be inclusive of all taxes, GST, duties, Cess, insurance, freight including loading and unloading etc., on **FOR freight paid destination basis** upto any Mandal head quarter in AP state. The rate shall also include interstate taxes if any. **The rate should be quoted on GST paid basis only.**
4. The manufacturer should also give declaration in Annexure – IV of application. All the pages of the Application & Annexures, are to be signed by the manufacturer and submit the same in sealed cover to Corporation along with EMD.
5. The EMD of the participating firm whose application is not technically qualified will be returned on finalization of the EOI process. In case of technically qualified applicants, the EMD shall be refunded to the manufacturer only after satisfactory completion of contract without any interest. The EMD will be forfeited in case of defaulting suppliers during contract period and also if the terms and conditions in agreement are violated by the manufacturers.
6. The applicant has to submit the samples of Traps & Lures along with the application for physical verification and analysis of lures. Clear embossing of manufacturing firms' name must be present on their Pheromone Traps supplied. **The Trap supplied must be made of virgin plastic only. This must be supported by a certificate from CIPET (Central Institute of Plastics Engineering & Technology) which is mandatory.** Similarly in case of pheromone sex lures, the cover containing lures must have the manufacturer's name, shelf life etc. The Lure should be **hermatically sealed** to avoid any leakage leading to loss of quality. Supply of sample after the prescribed **closing date and time** will not be accepted under any circumstances.
7. The last date for submission of EOI is **12.00noon on 22.8.19**. The Technical Bids will be opened at **2.00PM on the same day** and preliminary scrutiny shall be conducted by the Technical Committee.
8. The Firms whose application is technically qualified, the price quotation will be opened and if, after opening of Commercial bid, it is found that the lowest rate (L1) quoted is high and is not acceptable, the Committee shall have the right to call for negotiations and fix up **final L1 rates** for supply of the traps & Lures.
9. The Application shall be signed only by the proprietor, if it is a proprietary concern. The necessary documents of ownership are to be enclosed.
10. If it is a partnership, one of the partners or a person authorized by the partners shall sign the EOI. **Copy of the partnership deed shall be submitted to know the person authorized to sign the document.**

- 11.If it is a public / private limited company, the EOI should be executed in the manner laid down in the said company's Articles of Association.
- 12.**The authorized person representing the firm i.e. (a Director/Senior employee who can take decisions on behalf of the firm)** shall invariably attach authorization letter (Annexure-VI) obtained from the competent authority as per rules of the firm/ company to Application for EOI to sign on the EOI and to participate in the process.
- 13.**Any representative shall represent only one Firm with the authorization letter and valid identity to participate in the EOI Process and the firms intending to apply should ensure this.**
- 14.The rates quoted in the price list offered by the firm should be firm and **valid up to one year from the date of the agreement.** The Corporation will not entertain any upward price revisions during the validity period of contract. The validity of the rates may be extended as per mutual consent and with the permission of Commissioner and Director of Agriculture.
- 15.The firm should also furnish the product wise annual production and the turnover details for **the last five years.**
- 16.All the columns of the Application shall be duly, properly and exhaustively filled in and the rates and units/packing size shall not be over written. The rates shall be both in figures and words.
- 17.The corrections, if any, must be signed by the applicant before submission itself. In the event of faulty information, the EOI is liable for rejection.
- 18.The applicant should sign on each and every page of Application and on all the additional documents submitted.
- 19.The VC & MD of the Corporation and/or the Technical Committee reserves the right to reject the Application even after verification of Technical details or price details without assigning any reason whatsoever. Further, the Application can also be rejected due to delay in submission of documents sought for (or) if the supplier was a defaulter already in the previous transactions of Government supplies.
- 20.The successful Applicant shall execute an agreement in the fixed format on Rs.200/- Non Judicial stamp paper as per the existing procedure at his cost and submit along with the acceptance letter within (7) days from the date of communication of acceptance of application by the Corporation.
- 21.The Applicant shall not sell products of same specification during the relevant period at a lower price than the rates offered to Corporation, to any agency or person anywhere in A.P. If such incident is noticed, the Corporation shall restrict all payments to such a lower rate and take further action as deemed fit.

22. The required products shall be **supplied within 7 days** on placement of purchase orders by Corporation from time to time during the contract period. **In case delay in supply is noticed in more than 3 instances during contract period, such firms will be deleted from the list.**
23. On placement and acceptance of Purchase order, if the supplier defaults his obligation as per the terms of supply order, such supplier will be blacklisted duly terminating the contract Agreement. The Corporation reserves all rights to make alternative arrangements to procure them from any alternative source and the difference of additional cost paid, if any, will be recovered from the defaulting supplier through appropriate action, besides forfeiting of EMD.
24. **The manufacturer is solely responsible for the quality of the stocks supplied under this EOI. In case, the materials supplied are found to be substandard or defective, the materials will be rejected and all payments due will be withheld until the matter is settled.**
25. The Applicant has to pay back the value of substandard stock supplied / held alongwith interest at bank / credit rate immediately, if the payment is already made and the supplier will be solely held responsible for any consequences arising in the field due to sub-standard materials. Such firms will be black-listed for supply of substandard material.
26. **The approved manufacturer shall ensure replacing the material due for expiry without waiting for information from Corporation/Department within a week time at his own cost.**
27. **The approved manufacturer shall not assign or transfer this contract or any part of it to other agencies/suppliers and has to supply his own products only.**
28. The Lures supplied should be within the required limit of shell life considering the usage of Lure by the farmer.
29. The products supplied shall be with sound packing as per the specifications.
30. The Applicant shall be accountable for the quality and quantity (sub-standard/under weight) of the material supplied.
31. The Corporation reserves the right to accept/ reject/modify any or all the clauses without assigning any reasons what so ever and its decision will be final.
32. **The manufacturer shall specify the billing point, whether local supply or interstate supply. and the rate with applicable GST and other duties/cesses.**

33. In case of any dispute or difference arising out of this process and terms of agreement between the two parties, the parties shall first attempt to settle the dispute through mutual and amicable discussions. If the dispute is not resolved through such discussions, the matter shall be referred to the Special Commissioner of Agriculture, A.P, who shall conduct arbitration as per provisions of Arbitration & Conciliation Act, 1996 and whose decision is final and binding on both the parties.
34. It is further agreed by both the parties that Courts at Vijayawada alone have the jurisdiction.
35. If, at any stage of EOI process, it comes to knowledge that any supplier is involved in any fraudulent practice or misrepresentation of the facts or tried to influence the selection process or indulged in any corrupt activities in competing with others, the agreement can be rejected / cancelled and the EMD forfeited.
36. The Applicant shall be liable for blacklisting and further prosecution, if he fails to adhere to the above conditions.
37. The Corporation representative(s)/Department Officials shall have the right to inspect randomly the quality of the material to ascertain their conformity to the prescribed standards of the material.
39. Calling of Applications shall not confer any right on the supplier to insist for supply orders.
40. The Applicant shall furnish the prescribed documents mentioned in Annexure-III & V.
41. Corporation reserves the right to accept or reject in part or full or all the offers without assigning any reasons whatsoever.
42. The manufacturer should furnish the technical brochure, including items, usage, advantages of the products to the farmers.
43. The indent quantity may be decreased/ increased as per the requirement from the District JDAs. The firms don't have any right to demand on quantity.
44. Depending on the seasonal conditions, the Department of Agriculture may require huge quantity of material in short period to supply in the 13 districts. In view of this, those firms who have filed the EOI, technically qualified and are willing to supply the material **at the L1 rate finalised**, will be given an opportunity/empanelled to supply the items for which they have offered.

45 **Generally, the Department will endeavour to distribute the total indented/supplied quantities under the subsidy schemes. In case due to any seasonal failures or other unforeseen conditions/reasons, certain stocks are leftover, such leftover quantities at each destination supplied by the firms shall be taken back by them without raising any objection or claiming any payment for such leftover stock and all the incidental charges for taking back the stock to be borne by the supplier without any objection.**

TERMS OF PAYMENT:

1. Payment for the stocks supplied shall be made on receipt of the Firm's tax invoices duly certified by the Corporation branch officers based on the proofs of stock receipt by the consignees to be furnished by the suppliers with the tax invoices and also after receipt of Utilization Certificates for the invoiced quantities and to the extent of both subsidy and non-subsidy components received from the Department.
2. The Corporation shall not be liable for any delay or payment of interest due for the delays in the receipt of the subsidy and non-subsidy for the stock supplied due to unavoidable circumstances or due to circumstances beyond the purview of the Corporation.

TERMS AND CONDITIONS

1. Tender without EMD will be rejected.
2. The EOI applicant's manufacturing unit should produce list of lab equipment and machinery certified by the concerned state Commissioner of Agriculture / concerned District Joint Director of Agriculture and also a certificate stating that the manufacturing unit has got well equipped laboratory and well trained personnel for manufacturing Pheromone and Delta Traps & Lures.
3. Copy of certificate of Registration of the firm to be enclosed.
4. Partnership agreement or other concerned documents to be enclosed.
5. GST Registration certificate (valid) to be enclosed.
6. The EOI application is to be accompanied by one sample of each product along with quality test report from Govt.of India / any Research Institute must be submitted along with the Technical bid.
7. Supplies should be accompanied with test report from any Govt of India Institution for each of the batch supplied to the department.
8. Copies of R& D recognitions by Govt. of India.
9. The EOI applicants from out of State should have a Branch office with billing facility with GST registration in Andhra Pradesh. The Branch office should take care of A.P. Marketing business.

Product Specifications:

A) FUNNEL TRAP

A) Pheromone trap: (Funnel Trap)

The trap should have the specifications given below.

Clear embossing of manufacturing firm's name must be present on the Traps supplied.

B) Funnel shaped trap: This trap is generally used for trapping the moths of *Helicoverpa armigera*, *Scirpophaga incertulas* (yellow stem borer) etc.

Material to be used: Plastic (Virgin plastic, no re-processed material is permitted) and it should be able to withstand sunlight, rain water and wind at least for 6 months.

Supporting test report (CIPET) to be enclosed.

C) Colour: Yellow

D) Structure: The funnel trap shall contain 3 parts.

- a) Canopy : Diameter: 160 mm, Thickness: 2mm
- b) Funnel shaped trap base and
- c) A collection device (Polythene bag 30” length or 760 mm of 0.3 mm gauge)

There should be suitable provision for fixing the canopy to the trap base and also the pheromone lures.

E. Trap base:

1. Diameter of the mouth 120 mm
2. Height of the funnel 90 mm
3. Diameter of the bottom hole 30 mm

Should possess a ‘L’ or ‘T’ shaped handle or any other device by which the ‘trap’ may be fixed to the support.

Conforming to the provision in the canopy, the ‘trap base’ shall be provided with 3 stalks for fixing the canopy to the ‘trap base’. The canopy should firmly rest on the stalks so that the canopy is not dislodged due to wind, and provide groove for fixing collection device by means of a plastic ring.

F. Collection Device: It should be made of thick non-collapsible transparent, white polyethylene material of similar diameter as that of moth of trap base and close at the bottom. It should withstand wind, temperature and rain water. Gauge should be at least 0.3 mm. It should be fixed to the trap base with plastic ring in such a way that the device remains attached to the trap under field conditions.

Length: 760 mm in case of bag.

B. Delta Trap for Groundnut leaf miner (Oil seeds):

For Sl. No. 1 to Sl. No.4:

The chemical load range for different pests must be mainly to monitor the pest incidence as part of IPM. The firm has to ensure that the specified amount of lures must be impregnated in the dispenser, which should trap the male moths of specified insect for 30-45 days effectively under field conditions.

The lures should have minimum shelf life of 8 months from the date of supply.

PACKING:

Dispensers (septa) must be made of silicon / rubber/ PVC and it should be supplied in aluminium foils and contain not more than two lures per pack with each lure packed separately. Each pack should bear batch number, date of expiry of the material and efficacy / duration of lure.

For Spodoptera frugiperda at Sl.no.5 (Fall Army Worm)**Chemical Blend to be used:**

Z-9 Tetradecenyl Acetate (Z9-14 Ac), Z11-Hexadecenyl Acetate (Z11-16Ac) and Z7-Dodecenyl Acetate (Z7-12Ac) in ratio of 87:12.5:0.5.

The above chemical load range is required to monitor / mass trapping of adult moths as part of IPM. The firm has to ensure that the specified amount of the said chemical blend must be impregnated in the dispenser, which should trap the male moths of specified insect for 30-45 days effectively under field conditions.

The lures should have minimum shelf life of 8 months from the date of supply.

PACKING:

Dispensers (septa) must be made of Polyethylene vail(Polyvail) and it should be supplied in aluminium foils and contain not more than two lures per pack with each lure packed separately. Each pack should bear batch number, date of expiry of the material and efficacy/ duration of lure.
