TERMS & CONDITIONS:

1. The offer should be in a “Sealed cover” duly super scribed “Tender for purchase of Bulldozers / Transport Vehicles / Dozer Spares/Scrap.
2. Sealed tenders should be submitted to the Offices at the addresses given below by Regd. Post with Ack. due or in person so as to reach not later than the specified dates and time. Tenders received after the due date and time shall automatically stands rejected. Receipt of tender by the Corporation within the stipulated date and time shall be the criteria and not the posting of tender by the Tenderer. No correspondence shall be entertained in this regard.

3. Offers made through sealed tender in the prescribed form purchased from the Corporation duly signed, shall only be considered.
4. The tenderers / bidders should sign at the end of the each page of the terms and conditions of the sale and return the same along with the signed tenders.
5. Offer should be made clearly for each item in case of Dozers/Transport Vehicles, per KG incase of Scrap, per Ltr. incase of waste Oil etc. as indicated in the list. The offers should be made both in figures and words, in ink, or typed. Alteration, modification and deletion, if any, should be attested with full signature of the tenderer.
6. Each offer should be accompanied with E.M.D. of 25% of the value **excluding Taxes** offered for the disposable material.
7. The E.M.D. should be remitted by means of crossed Demand draft drawn on any scheduled bank in favour of "A.P.STATE AGRO INDUSTRIES DEVELOPMENT CORPORATION LIMITED" payable at VIJAYAWADA. No other mode of payment shall be accepted. Offers received with insufficient EMD/without EMD shall automatically stands rejected. The EMD shall not carry any interest. After completion of the auction for all lots, the sealed tenders shall be opened by the members of Tender-cum-Auction Committee in the presence of tenderers/bidders present at that time. If the tendered offer is lower than the bid offer made at the auction, demand drafts enclosed to the tender will be returned back to the unsuccessful tenderers who are present on the spot and for others the demand drafts will be dispatched to them by Registered post with ack.due.
8. Only the EMD of first highest tenderer/bidder shall be retained with the Corporation till their offers are finally accepted or rejected. The intending bidders including tenders intending to participate in the open auction should pay an initial deposit of Rs.5,000/- for participating in auction. The

initial deposit amount will be returned to the unsuccessful bidders on competition of auction at the respective places. Immediately after fall of the hammer (final buzzer) for that specific lot, the first highest bidder should pay the EMD @ 25% of the bid amount for each lot, failing which the initial deposit paid by them shall stand forfeited. Cash receipt will be issued for the EMD by an authorized Officer of the Corporation.

9. The price offered for the material is **exclusive of all taxes, duties and 1 % incidental charges.**
10. After completion of auctions for all lots on the specified dates at the respective branch the sealed Tenders will be opened by the members of tender cum auction committee in the presence of tenderers who are present at that time.
11. Consolidated offers for the total lots put for sale will also be accepted after the conclusion of the auction of individual lots, provided the tenderer should have participated in the auction of all the lots.
12. The Tenderers / bidders can inspect the material during office hours on any working day at the respective places duly obtaining the permission from the officer concerned.
13. The offers are deemed to have been made considering that the tenderers / bidders have inspected the material to their satisfaction. No segregation/classification of machinery/equipment/spares/scrap from the lots offered shall be permitted. The quantities mentioned in the tender/auction are only approximate and the successful tenderer/bidder should pay for the actual quantity offered for sale if the Corporation offers it on weight basis in case of scrap and take delivery of such extra quantity on payment of proportionate cost. However, the tenderers / bidders should pay for the approximate quantity after weighing, the Corporation shall refund the amount for such short quantity.
14. In other cases the successful tenderers / bidders shall pay the full amount including taxes applicable and other duties, if any and incidental charges by way of demand draft drawn on any Scheduled Bank in favour of "A.P.STATE AGRO INDUSTRIES DEVELOPMENT CORPORATION LIMITED" payable at VIJAYAWADA within 20 calendar days on receipt of

intimation of acceptance of their offers from the Corporation. If the total value of the material offered is not paid after receipt of the intimation notifying the acceptance by the Corporation within the stipulated time, the EMD shall be forfeited. The Corporation reserves the right to dispose off the material tendered or auctioned which were not paid in full and forfeit EMD received from the tenderer/bidder.

- 15.** The successful tenderer/bidder should make his own arrangements including weighment at their expenses, in case of delivery by weight and lift the material purchased by them within 20 calendar days from the date of issue of delivery order by the Corporation
- 16.** 0.1% value of the total tendered/auctioned amount shall be charged per calendar day for the belated period as ground rent up to a maximum of 20 calendar days if the material purchased is not lifted from the respective place within the stipulated 20 calendar days.
- 17.** If the material is not lifted even during the extended period of 20 calendar days duly paying the ground rent as per clause 16, it shall stands forfeited to the Corporation. However, in deserving cases, the VC & MD at his discretion may allow either refund of the amount not exceeding 70% of the sale value of permit delivery of the material duly imposing additional penalty.
- 18.** The goods shall be and remain with the Corporation at the risk of the buyer from the date of communicating the acceptance of the offer till the date of final lifting.
- 19.** Delivery to proxy shall be undertaken by the Corporation at the purchasers sole risk and responsibility and no claim shall lie against Corporation on any account whatsoever if delivery is obtained by wrong person.
- 20.** At the time of payment of money and lifting the material from the Corporation's premises the tenderer / bidder have to abide by the rules and regulations of the Corporation.
- 21.** The buyer shall be responsible for any damage that may be caused to the Corporation's premises/property at the time of taking over or removing the material, and shall make good of the loss so sustained.

- 22.** The offer shall be valid for a period of 1 month from the date of opening the tender/auction. However, the Corporation at its discretion may extend the validity for further period of 1 month due to administrative reasons.
- 23.** The employees of Corporation and their kin are not allowed to take part in the tender/auction.
- 24.** The Corporation reserves the right to withdraw the sale of material in part or in full from the tender/auction or to reject highest tender/bid amount without assigning any reasons, in part or in full thereof.
- 25.** In the event of first highest tenderer / bidder fails to pay the amount and lift the material within the stipulated time, the Corporation reserves the right to offer the same to the second highest tenderer / bidder at the highest price.
- 26.** The tenderer/bidder shall furnish their complete postal address along with e-mail and wherever available telephone and fax numbers.
- 27.** The Corporation shall not give any guarantee in providing R.C.Books of all the machinery which were earlier registered with RTA as all the transport machinery were registered long back. The R.C.Books wherever available will be given without stoppage entries and the tenderer/bidders should make their own arrangements for completing the entries in R.C.Books of machinery purchased by them. Letter if any required from the Corporation shall however be provided. The successful bidder/tenderer shall inform the concerned R.T.A. within 30 days from the date of taking delivery of the vehicle and get the ownership transferred in their favour. Once the delivery is affected, the Corporation is deemed to have been completed the transaction.
- 28.** Taxes and insurance paid, if any, for the tendered vehicle have to be proportionately reimbursed by the tenderers/bidders at the time of taking delivery.
- 29.** The Vice Chairman and Managing Director or his authorized representative reserves the right for acceptance or rejection of all or any of the offers without assigning any reasons. In case of any disputes between the parties the decision of Vice Chairman and Managing Director

or an arbitrator appointed by him is final and legally binding on all the parties.

- 30.** Disputes arising out of the above transaction, if any, shall be subject to the jurisdiction of the Courts at VIJAYAWADA only.
