#### **Preamble:**

The Panchayat Raj & Rural Development, Government of Andhra Pradesh State is implementing the WDC-PMKSY2.0 watershed programme under subsidy schemes under PSI component for supplying **various type of Agricultural Implements** to the farmers in the State of Andhra Pradesh through the Nodal Agency A.P.S.Agro Ind. Dev. Corp. Ltd. (APSAIDCL), Government of Andhra Pradesh.

Technical & price quotations are invited from reputed manufacturers for supply of various Agricultural Implements & materials.

The Bidders intending to participate in this short Expression of Interest (EOI) schedule are required to get enrolled/registered on AP State E-Procurement portal. Enrolment /Registration and subsequent empanelment in the above portal is mandatory.

#### A. ELIGIBLE CONDITIONS FOR OFFEROR(S):

- 1. Firms should have Manufacturing license for Agricultural Implements from the Government should have minimum 3 years' experience in production.
- 2. The manufacturers who supply Agricultural Implements should enclose commercial test report from FMTTI centers or any institutions recognized by Ministry of Agriculture GOI as per their guidelines.
- 3. The manufacturers who supply Agricultural Materials should enclose CIPET test report from the institutions recognized by Ministry of Agriculture GOI as per their guidelines
- 4. The Manufacturer of PVC and Sprinklers must be empaneled with APMIP and necessary certificate which is in-force shall be enclosed.
- 5. Manufacturers whose models are approved by Ministry of Agriculture, Government of India as per the latest eligibility list only need apply.
- 6. The Manufacturer shall have a full-fledged workshop with sufficient technical personnel

and dealers network to attend after sales service.

- 7. The Manufacturer should have valid GST, ISO, ISI, BIS, PAN & Udyam registration as and where applicable according the implement/material.
- 8. Income tax returns for the FY 2022-23, 2023-24, 2024-25.
- 9. The Manufacturers must submit three E-invoices (one invoice on each implement) for last three years.
- 10. One bidder for one application will only be allowed.

#### B. INSTRUCTIONS FOR SUBMISSION OF SHORT EOI SCHEDULE:

- 1. The bidder (s) shall submit only Commercial Test Reports in hard copy in a sealed cover duly addressing on the envelope VC&MD, APAGROS, Vaddeswaram on or before bid closing date & time in the box provided at APAGROS headquarters. Other eligible criteria documents shall be uploaded in E-Portal only.
- 2. Earnest Money Deposit (EMD) for an amount of Rs.1,00,000/- (Rupees Five lakhs only) & Rs.10,000/- EOI Schedule cost shall be paid online only in AP E-procurement Portal.
- 3. The EMD of un-successful bidder (s) shall be returned on finalization of short EOIs i.e., after agreement/price acceptance.
- 4. The EMD of successful bidder (s) shall be retained by the Corporation and refunded only after satisfactory completion of the contract. The EMD shall be adjusted against the Performance Guarantee for the successful bidder (s). This deposit will not carry any interest.
- 5. The Manufacturers who are having dealers & service centers in Government of Andhra Pradesh is only eligible to participate in the short EOI. List of Dealers for each district must enclose.

#### C. GENERAL TERMS AND CONDITIONS:

- 1. The Bidder(s) have to quote the prices as per the technical specifications given in the EOI schedule in Annexure-II.
- 2. The Price quotes of only those bidder(s) whose short EOI Schedules are Technically qualified for acceptance will be opened with due intimation to them.
- 3. Negotiations will be held as per the decision of the Technical Committee appointed by the Government of Andhra Pradesh. The aim is to reach agreement on all the points and sign a contract. Bidders who qualified in the technical bid shall produce three GST invoices raised on any government departments/agencies of last three year for the products quoted during price bid negotiation without fail.
- 4. The agreement period will be up to 31.03.2026 from the date of signing the agreement. The successful bidder (s) have to submit their price acceptance letter, agreement etc., within 02 days from the date of receipt of draft agreement. No Escalation charges will be paid for supply of equipment during the agreement period. Failure to supply the equipment due to price variation will attract

blacklisting of the firm and shall not be allowed to participate in the EOI process called by any Government Department in Andhra Pradesh for minimum 3 years under any subsidy schemes or in any project. The manufacturers should submit list of their dealers along with mail address & bank account details at the time of agreement without fail. No addition & deletion shall be entertained afterwards.

- 5. The supplies made shall be invoiced on GST invoice with serial No. of invoice printed on it. No invoice other than Tax invoice will be accepted.
- 6. a) Performance guarantee Deposit produced by the successful Bidders (s) shall be forfeited and alternate arrangements shall be made, if the firm does not fulfill the obligation of supply of stocks as per orders / specification / quality and alternate arrangements will be made for procurement of such products and any additional cost incurred in this regard will be recovered from the concerned firm. The arbitration will be initiated and shall remain final.
  - b) The responsibility of quality and quantity (eg. Misbranding / underweight) of the implement supplied lies with supplier only.
- 7. All those Manufacturers, who had filed valid EOI and are willing to supply the Agricultural implements at the accepted rate will be given opportunity to supply the implements for which they have offered subject to the acceptance of the terms and conditions.
- 8. The approved firms shall supply the ordered implements as per terms and condition within the stipulated time indicated in the purchase order placed from time to time to the beneficiary at WCC Headquarter/Micro-Watershed Level and obtain acknowledgement from the beneficiary on the day of delivery. They shall also ensure that all the components shall be made available through dealer's network at least for a period of **three years** from the date of supply of the unit on payment basis beyond warranty period.
- 9. The implements supplied must be covered with warranty for one year from the date of supply against any defective manufacture / workmanship etc. Repairs / Replacements / servicing shall be attended free of cost within the warranty period and the transport charges are to be borne by the supplier within 7 days from the date of intimation at the Project Officer, WCC/ Micro-Watershed.
- 10. If the supplying firms fail to supply the implements within the scheduled time i.e.15 days from the date of receipt of purchase order, the Performance Deposit shall be forfeited besides initiating action as per procedure and also will not be allowed to participate in future EOIs. **Stringent criminal action will be initiated against default suppliers apart from initiating action through RR Act**.
- 11. Liquidated damages will be levied at the rate of 0.5% of the total value of work per week up to a maximum of 5% in case of default in the supply of implements as per schedule.
- 12. The supplier has to deliver the indented equipment to the concerned beneficiary in the presence of VIA at RSK through mobile app.
- 13. The loading, un-loading charges and demonstration expenses, should be borne by the supplier only.
- 14. Random inspection of all implements distributed under subsidy schemes will be conducted by suitable committee / team appointed by the Commissioner, PR&RD before / after the implements are supplied to the beneficiaries.

- 15. The Manufacturers shall provide detailed operational and maintenance manuals, parts catalogue (in the Telugu language) at the time of supply of the implements to the beneficiary and awareness should be created to beneficiaries to follow the instructions.
- 16. The bidder (s) have to quote the price only as per the technical specifications given in the EOI schedule in Annexure-II.
- 17. A.P State Agro Industries Development Corporation Limited reserves the right to award the EOI either in part or full or to empanel on rate contract or follow any other suitable procurement procedure. AP Agros at its sole discretion and without assigning any reason thereof, reserves the right to accept / reject any or all bids at any stage of the EOI process.
- 18. In case of any dispute or difference arising out of the agreement between the two parties relating to any aspect of the agreement, the parties should attempt to settle the dispute through mutual and amicable discussions. If the dispute is not settled through such discussions, the matter shall be referred / settled as per provisions of Arbitration & Conciliation Act.1996.
- 19. It is further to be agreed by both the parties that all differences and disputes if not resolved as above, shall be got remedied through the Court of Law of Vijayawada jurisdiction only.
- 20. The EOI Schedule can be rejected if at any stage of the procurement process, it comes to knowledge that any bidder (s) is involved in any fraudulent practice or misrepresentation of the facts or tried to influence the selection process or indulged in any corrupt activities in competing with others.
- 21. The Manufacturers shall be liable for blacklisting and prosecution, if they fail to adhere to the above conditions.
- 22. The Manufacturers who are manufacturing above implements should not be allowed to take the dealership of the same product of other firms.
- 23. The bidder has to furnish their authorized dealers list along with the agreement duly enclosing a copy of acceptance letter from the dealer. Additional dealer communicated to the corporation separately for empanelment under the subsidy schemes shall not be considered for communication to the department.
- 24. The Manufacturing company which is facing Criminal cases is not eligible to participate in the EOI process called by the corporation.
- 25. Once the Manufacturer is empaneled under any subsidy scheme, their performance guarantee deposit shall be returned only after completion of the financial year, if no issues are pending against the firm / dealer.
